

General Terms and Conditions

1. Solely the following terms and conditions apply to all orders placed with DAD Deutscher Adressdienst GmbH (hereinafter publisher). Any diverging agreements are subject to express written confirmation by the publisher. The contractual agreement comes into force as soon as the signed order is sent to the publisher (can also be sent by fax or email) provided that it is not revoked within two weeks from the date of order by registered letter (the date of the postmark is essential).

2. The client agrees with the fact that any future correspondence can be written in English or German if necessary.

3. If you are a resident in the EU and provide us with a valid VAT-ID number, we charge our services without German VAT. If we do not receive from you the appropriate VAT-ID number, we are required to charge our services with German purchase tax.

4. The publisher reserves the right accept or to refuse the advertisements requested by the orderer, and to take decisions on placing and sector classification. Solely the orderer is responsible for supplying accurate details and documents for the advertisement. If the details are not sent within four weeks after the order has been placed, the publisher will use the available documents for the advertisement's layout. The advertisement will continue to be published in the same form unless the publisher receives any instructions to the contrary. The orderer is responsible for providing timely notification of amendments. Proofs shall only be forwarded on request. In case the orderer receives a proof of the insertion and does not send it back in time the proof will be considered as confirmed.
